

TERMS AND CONDITIONS OF USE OF THE CONTAINER PETROL STATION

ARTICLE 1 DEFINITIONS

- a) **Vessel** - any structure capable of floating on its own or temporarily below the water surface, self-propelled or propelled (towed or pushed) or permanently anchored, with one or more of the following uses: research, communication, storage or living, military, industrial, recreational, fishing, signalling, technical, transportation, special.
- b) **Inland waterway vessel** - a vessel navigating the rivers, canals, lakes that make up the inland waterway system.
- c) **Container petrol station** - a set of tanks together with necessary infrastructure used for supplying vessels with liquid fuel of diesel and PB type.
- d) **Customer** - an entity purchasing fuel; the customer may be a single individual, a legal entity or an organisation bringing together various persons. In addition, in this case, the customer is defined as the person in command of the vessel or his/her crew member appointed by the person in command of the vessel.
- e) **Boatswain** - A person responsible for the proper operation of the Marina where the container petrol station is located.
- f) **Oil Kit** - A set used to secure the work area and remove oil-based substances.
- g) **Environmental First Aid Kit** - A kit for dealing with oil and chemical spills and leaks.
- h) **Manager** - ATM Inwestycje Sp. z o.o. with registered office in Bielany Wrocławskie at ul. Dwa Światy 1, NIP 1080004301.

Article 2 SUBJECT MATTER

- 1) The Terms and Conditions lay down the rules for the refuelling of vessels from the container petrol station.
- 2) The Boatswain and the Customer using the container petrol station are obliged to familiarise themselves with these Terms and Conditions and observe their provisions.

Article 3 TYPES OF FUEL AND CHOICE OF THE TYPE OF REFUELLING

- 1) The Customer arriving at the container petrol station can choose between the following fuels: motor gasoline 95 code CN 271045 and diesel oil code CN 27101943,27102011.
- 2) The Customer has the option of paying for purchased fuel by cash or credit card.
- 3) The Customer receives a receipt or an invoice after the purchase. Only Customers who undertake business activity may receive an invoice, and this should be reported to the Boatswain before refuelling.

Article 4 REFUELLING OPERATION

- 1) There shall be no unauthorised persons in the immediate vicinity of the container petrol station during refuelling.
- 2) Smoking and the use of open fire is forbidden in the immediate vicinity of the petrol station.
- 3) Two persons are required for proper refuelling : The Boatswain and the Customer.
- 4) The Customer notifies the Boatswain of a wish to refuel, or makes an appointment with him directly, specifying the time, type and quantity of fuel.

- 5) It is the Customer's responsibility to moor the vessel safely and properly at the container petrol station in a way that allows easy and safe access to her filler.
- 6) The engine in the vessel must be switched off before refuelling.
- 7) The use of a mobile phone is prohibited during refuelling.
- 8) The Boatswain hands the Customer the filling gun and extends the dispenser hose.
- 9) If the gun is correctly positioned in the tank filler the Customer can start refuelling by pressing the trigger of the refuelling gun..
- 10) While refuelling, observe the environment and the correct operation of the dispenser
- 11) If a fuel leak is observed, the refuelling should be stopped immediately and the " Oil Kit" or the " Environmental First Aid Kit" should be used.
- 12) When refuelling is complete, the customer carefully removes the refuelling gun and gives it back to the Boatswain.

Article 5 VALIDITY AND AMENDMENTS TO THE TERMS AND CONDITIONS

- 1) The Terms and Conditions are effective as of 1st September 2022.
- 2) The Manager reserves the right to amend the Terms and Conditions.
- 3) Matters not regulated by these Terms and Conditions shall be governed by generally applicable provisions of Polish law.
